**ELIGIBILITY:** Competitors must be members of the National Rifle Association and the Pennsylvania Rifle and Pistol Association or their home state association. Juniors may be either individual members of the NRA or NRA affiliated club.

**CLASSIFICATION:** Competitors will compete in either civilian or service (Active, Reserve, and National Guard) category. The NRA Classification System will be used. Unclassified competitors will fire in the Master class.

**AWARDS:** Awards will be broken down into Open Winner and High Junior. One award per each five (5) in each class. If less than five (5) competitors in a class, the class will be combined with the next higher class.

**RIFLE:** The Service Rifle as defined by NRA Rules: 3.1; 3.1.1; 3.1.2; (M-1, M-14, M-1A, M-16 and AR-15).

**TRIGGERS:** Triggers will be weighed prior to commencement of firing. 0700 AM day of match.

**RULES:** Current NRA High Power Rules will apply.

**TARGETS:** SR, SR3, and MR targets will be used.

**DUTIES:** Competitors will be required to pull targets and keep scores.

**FOOD:** Food and beverage are **not** available. There will be NO lunch break.

**COURSE OF FIRE:** 0800, 12 JULY 2008

**Match 1:** 20 shots slow fire, standing position, 200 yards, 2 sighting shots(any position), 20 shots for record, time 22 minutes.

**Match 2:** 20 shots rapid fire, standing to sitting or kneeling, 200 yards, 2 sighting shots, 20 shots for record, time 60 seconds.

**Match 3:** 20 shots rapid fire, standing to prone, 300 yards, 2 sighting shots, 20 shots for record, time 70 seconds.

**Match 4:** 20 shots slow fire, prone, 600 yards, 2 sighting shots, 20 shots for record, time 22 minutes.

**Match 5:** Rapid Aggregate (Matches 2 & 3)

**Match 6:** Slow Aggregate (Matches 1 & 4)

**Match 7:** Grand Aggregate: (Matches 1, 2, 3, 4) PA State Champion

**Sighting Shots:** All sighting shots must be fired and scored.

**Entry fee:** \$20.00

**Eligibility:** Any citizen of the United States, sixteen (16) years of age on the date of the match.

**AWARDS:** Credit towards Distinguished Rifleman Designation for the top ten (10) % of non-distinguished shooters. To be awarded by the CMP.

**RIFLE:** The Service Rifle as defined by NRA Rules: 3.1; 3.1.1; 3.1.2; (M-1, M-14, M-1A, M-16 and AR-15).

**AMMO:** Competitors will supply their own, safe ammo.

**RULES:** Current NRA High Power Rules will apply.

**TRIGGERS:** Triggers will be weighed prior to commencement of firing. 0700 AM day of the match.

**TARGETS:** SR, SR3, and MR targets will be used.

**DUTIES:** Competitors will be required to pull targets and keep scores.

## 4-6 Man Team Match

**0800** hours, 11 JULY 2008

**LOCATION:** Reade Range, Allemans, PA (See Map)

**ENTRIES:** Entries will be accepted the day of match. Entries close 11 July 2008 to range capacity of **12 teams**.

**Entry fee:** \$10.00/team member

**Eligibility:** Any citizen of the United States. Organization and 'pick-up' teams allowed.

**AWARDS:** First, second and third place teams will receive awards.

**RIFLE:** The Service Rifle as defined by NRA Rules: 3.1; 3.1.1; 3.1.2; (M-1, M-14, M-1A, M-16 and AR-15).

**AMMO:** Competitors will supply their own, safe ammo.

**RULES:** Current NRA High Power Rules will apply.

**TRIGGERS:** Triggers will be weighed prior to commencement of firing. 0700 AM day of the match.

**TARGETS:** SR, SR3, and MR targets will be used.

**DUTIES:** Competitors will be required to pull targets and keep scores.

**FOOD:** Food and beverage are **not** available at the range. There will be NO lunch break.

**COURSE OF FIRE:** 0800, 11 JULY 2008

10 shots slow fire, standing position, 200 yards, time 10 minutes. **Pair firing required.**

10 shots rapid fire, standing to sitting or kneeling, 200 yards, time 60 seconds.

10 shots rapid fire, standing to prone, 300 yards, time 70 seconds.

20 shots slow fire, prone, 600 yards, time 20 minutes. **Pair firing required.**

From I 80 – Leave I 80 at Milesburg, go South on Rt. 220 to Tyrone. At Tyrone, take Rt. 453 West to Rt. 253. Turn South on Rt. 253 to town of Allemans. In center of town turn right (West) and travel ½ mile to Whipper Road. (Church and cemetery on right). Turn left on Whipper Road. Follow signs to Range.

From Rt. 22 for Western shooters. Turn North on Rt. 53 at town of Cresson. Follow Rt. 53 to town of Van Ormer. Turn right on Rt. 253 to Allemans. Turn Left (West) in center of town and proceed as above.

From Rt. 22 for Eastern shooters. Turn North on Rt. 220 at Hollidaysburg. Proceed on Rt. 220 to Bellwood. Turn left on Rt. 865 at Bellwood and follow Rt. 865 to Glasgow. At Glasgow turn right on Rt. 253 to Allemans. Turn left in center of town and proceed as above.
